

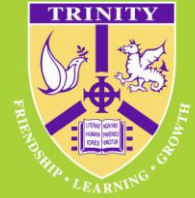

## NEW RESIDENT AWARDS 2018

**New residents** who are in full-time tertiary studies are eligible to apply for Trinity Awards. Each Award is worth \$2000 in the first year of residence in Trinity. All recipients are eligible to apply for Trinity Returning Resident Awards the following year.

### GUIDELINES

To qualify for a Trinity Award, applicants are required to demonstrate a commitment to their studies and appropriate progress and achievement.

Applicants will be considered on the basis of their contribution to the community. Qualification for Trinity Awards can be demonstrated at School, at University, in the local community or at a state or national level.

For example, consideration will be given to:

- Experience in leadership roles.
- Participation and contribution to charitable or service activities or groups, or to environmental or sustainability projects.
- Membership and contribution to sporting or other community groups. Includes roles in coaching, umpiring and mentoring.
- Involvement and contribution in debating, music (instrument, vocal, solo or group), composing, drama, dance or other performance groups, visual arts and crafts, design, film making, directing, and writing.

### AWARD CONDITIONS

- 1 Where eligible, a resident may be granted an Award in more than one category except that no resident will be given more than one academic award in any one year. In all categories, confirmation of eligibility is required. A resident who is a recipient of a Fogarty Scholarship is ineligible for a Trinity Academic Award or Scholarship.**
- 2 The Award will be tenable for the academic year and will be credited to the recipient's College Account in two equal sums at the end of each semester. If a recipient leaves College before the end of a semester, then his/her entitlement will be forfeited for that semester.**
- 3 The College reserves the right to vary the terms of any award or to not make a particular award in any year.**
- 4 Awards will be presented at the Scholarships and Awards Dinner.**
- 5 Recipients are expected to meet their obligations as Award holders in the College.**
